## Personal Data

Personal data means any information relating to an identified or identifiable natural person (hereafter referred to as the data subject).

## Personal data collected

We receive, collect and store any information you enter on our website or provide us in any other way (e.g., name, email, organization, sector). Collected information may be provided by data subjects or collected automatically through monitoring tools.

## How information is collected

You directly provide the CE2COAST™ project with most of the data we collect. We collect data and process data when you:

- Join our mailing list.
- Voluntarily provide comments and feedback on any of our forums.
- Use or view our website via your browser's cookies.

## How we will use your data

Your personal information will be used for the specific reasons stated below only.

The CE2COAST™ project will use the information you provide so that we can:

- Email you with news and updates about the project's activities and events.

Like many site operators, the CE2COAST™ project collects information that web browsers send whenever you visit our website. This log data may include information such as your computer's Internet Protocol (IP) address, browser type, browser version, what pages of our website are visited, the time and date of each visit, the time spent on those pages, and other statistics.

The CE2COAST™ project processes the personal data according to the General Data Protection Regulation (EU) 2016/679 (GDPR), implementing the necessary actions to guarantee the confidentiality, integrity, and availability of the personal data, and to avoid its loss, inadequate use, modification, and/or unauthorized access. The personal data collected are not provided to third-party entities or used for any other purposes beyond that necessary to fulfil contract terms and legal obligations, to communicate with and notify the owner of the personal data, to process the personal data, or for any other consented purpose strictly defined when the personal data were collected. The personal data collected will only be stored for the period necessary for their processing.

## How we store, use, share and disclose our data subjects' personal information

The CE2COAST™ project is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to communicate and disseminate our project to you. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall. ## How we communicate with our data subjects

## Your data protection rights

XSRF-TOKEN	Used for security reasons	Session	Essential
bSession	Used for system effectiveness measurement	30 minutes	Essential
hs	Used for security reasons	Session	Essential
SSR-caching	Used to indicate the system from which the site was rendered	1 minute	Essential
Session	Used in connection with user login	2 years	Essential
